



THE Earl of Clarendon has received a Despatch 1 from Major Simmons, Her Majesty's Commissioner attached to the army of Omer Pasha in Asia, of which the following is a copy:

Camp, Shangwano, 7th November, 1855. My LORD,

I HAVE to inform your Lordship that Omer Pasha, having collected a depôt of provisions at Tchimshera, moved on by the sea-coast to the mouth of the River Ertiss-Tchal, where a standing bridge was immediately constructed for the passage of the troops. The advanced guard, consisting of 16 battalions of infantry and 3 battalions of chasseurs under Lieutenant-Colonel Ballard, the whole commanded by Ferhad Pasha (Baron Stein), moved on the 28th of October to the village of Ertiss-zkalsk.

From that day until the 1st November, his highness was occupied in sending up provisions to the advanced guard, in moving other troops to support it, and in establishing depôts at Godova, at the mouth of the Ertiss-Zchal, whence to provision his army for a forward movement.

sion his army for a forward movement.

On the first instant, the advanced guard moved about ten miles forward, having its advanced posts on the River Ingur, opposite an old ruined castle called Rocki, on the road to Sugdidi.

His highness joined the advanced guard himself on the 3rd instant, his total force consisting of 4 brigades (32 battalions) of infantry, 4 battalions of chasseurs, and 1,000 cavalry, with 27 field pieces and 10 mountain guns, or in all about 20,000 men; the remainder of his force, about 10,000 men, being employed to protect the depôts 10,000 men, being employed to protect the depôts at Godova, Tchinshera, and Soukoum.

On the 4th instant, his highness commenced constructing batteries on the right bank of the constructing batteries on the right bank of the Ingur, with the view of menacing the enemy by the ford at Ruki. These batteries were armed on the following night, and opened their fire on the morning of the 6th instant about noon. On the same morning his highness moved 3 brigades of infantry (24 battalions) with 3 batteries, with an advanced guard of 3½ battalions of chasseurs and four guns, under the command of Colonel Ballard, down the right bank of the river, a distance of about seven miles where a branch of distance of about seven miles, where a branch of the river was forded to an island, which is some

miles in length, and from a half to two miles wide.

After proceeding along this island for about two miles some Mingrelian militia were encountered near a ford, which crosses from the island to the left bank of the river; they speedily retired, when the enemy opened a fire of artillery and a heavy fire of musketry from the intrenchments on the left bank, thrown up for the protection of the

It very soon became evident, that to force a direct passage at this ford would be a very difficult undertaking.

His highness, therefore, while occupying the enemy at this ford, sent officers to the right and left, and fords were discovered in both directions; one about three quarters of a mile above or to the left of the main ford, the other about one mile and a half below or to the right of the main ford.

Troops were immediately sent to pass these fords; that to the left was unprotected. The passage was made by two battalions of infantry and three companies of chasseurs by about 4 P.M. His highness having entrusted me with this command I moved them by a waggon track through the forest unperceived by the enemy, until within about 600 yards of the position at the main ford, which his troops were occupied in defending from a direct attack. The Turkish troops advanced readily to the attack, taking the enemy and his intrenchments in reverse.

The enemy immediately fell back, and attempted to break through the Turks in column, but being met by a heavy fire in their front and on both flanks, they broke and dispersed in the forest, leaving us masters of the field, with 3 pieces of their field artillery and 6 ammunition waggons in our possession. At the moment that the Russian columns attempted to break through our line, I grieve to say that my aide-de-camp, Captain Dymock, 95th Regiment, having first had his horse killed under him, was wounded close by my

side, encouraging the Turkish troops. He died soon afterwards. His death is to be deplored, as Her Majesty has lost in him the services of a most promising and brave young officer, for whom his highness Omer Pasha has frequently expressed to me his high esteem. This young officer had accompanied me from the commencement of the war in Turkey.

Whilst this operation was proceeding on the left, a brigade moved down to the right, under Osman Pasha, and forced a passage in front of a force believed to be of 4 battalions, but without artillery and not entrenched. This operation succeeded; and soon after dark the Turkish forces on the left bank were in communication from right to left, and complete masters of that side of the river throughout this length.

The loss on the side of the Turks has been 310 killed and wounded, of whom 68 are killed, and 4

missing.

His highness has been pleased to express himself in terms of the highest satisfaction of the conduct of the British officers who accompanied his force. Lieutenant-Colonel Ballard conducted the advanced guard, and sustained a very heavy fire from the enemy at the principal ford, about 100 yards wide, from noon until dark at 5 P.M., occupying the enemy until his position was turned by the Turkish left.

Captain Caddell also rendered good service, attached as Second Senior Artillery Officer to that branch of the service. His interpreter was

killed.

The loss on the side of the enemy has not yet been ascertained, but up to the present time (noon) 347 have been buried, of whom eight officers, among which the prisoners report there are two colonels.

The prisoners report that there were eight battalions of infantry, besides a great number of Mingrelian militia opposite the main ford.

#### PRESENT.

The QUEEN'S Most Excellent Majesty in Council.

W HEREAS ships arriving from foreign parts VV at ports or places within the United King-dom, and proceeding in ballast to other ports or places within the United Kingdom, for the purpose of taking on board cargo for delivery within the United Kingdom are not exempted from compulsory pilotage when so navigating in ballast.

And whereas it is expedient that such ships should have the privilege of being exempt from

compulsory pilotage.

And whereas by the 332nd section of the "Merchant Shipping Act, 1854," it is enacted, that "every pilotage authority shall have power by "bye-law, made with the consent of Her Majesty "in Council, to exempt the masters of any ships, "or of any classes of ships, from being compelled to employ qualified pilots, and to annex any terms and conditions to such exemptions."

And whereas the Trinity House, being a pilotage authority, hath submitted, for the consent of

Her Majesty in Council, the following bye-law videlicet :-

"That all ships which shall arrive from foreign parts at ports or places in the United Kingdom, within the pilotage jurisdiction of the Trinity House, shall when navigating from thence in ballast to a port or place in the United Kingdom, for the purpose of taking on board cargo for delivery at some other port or place in the United Kingdom, be exempt from compulsory pilotage while navigating within the limits of such pilotage jurisdiction, subject, nevertheless, to the terms and conditions following, that is to say:-

"First. That the owner or master of the ship claiming exemption from such compulsory pilotage shall provide himself with a certificate of such exemption for the particular voyage therein specified; such certificate to be signed by the secretary or other proper officer of the Trinity House, and to be delivered to the owner or master of such ship, upon his making a declaration, setting forth that the said ship last arrived from foreign parts, and is about to navigate in ballast to some port or place in the United Kingdom, for the purpose of taking on board cargo, for delivery at another port or place, also in the United Kingdom, and such ports or places being named in such declaration. And further, that the master of such ship shall produce the said certificate, to any duly licensed Trinity House pilot, who shall offer his services to pilot being named in such declaration. such ship on such voyage; and such master shall on every such occasion, make an entry in the ship's log, of the offer by a Trinity House pilot; of the certificate of exemption having been produced to the said pilot; and of his services having been declined.

"Second. That in every case in which a certificate of exemption shall have been obtained by mis-representation, the person on whose application such certificate shall have been granted, shall forfeit double the amount of the pilotage to which the ship so exempted would, but for such certificate, have been liable; to be recovered in like manner as penalties are recoverable under the said Act; and

Third. That in every case in which a ship, for which a certificate of exemption has been granted, shall proceed over sea, either before or after arriving at the port or place specified in such certificate, without navigating with cargo to some other port or place in the United Kingdom, the pilotage to which such ship would have been liable, had a pilot been employed, shall be paid to the pilotage authority or sub-commissioners of the district, and be applied to the purposes of the pilotage fund."

Now, therefore, Her Majesty having taken the said bye-law into consideration, is pleased, by and with the advice of Her Privy Council, and by virtue of the power vested in her by the said recited Act, to declare her consent to the same, and the said bye law is hereby approved accord-

It is hereby notified, that the Right Honourable the Earl of Clarendon; K.G., Her Majesty's Principal Secretary of State for Foreign Affairs, has received from the Lords Commissioners of the Admiralty an official communication, addressed to them by Captain Baillie, R.N., late Senior Officer of Her Majesty's White Sea Squadron, announcing the raising, by the Allied Squadrons, on and from the 9th October last, of the Blockade of the Russian ports and places in the White Sea, the establishment of which Blockade was notified in the London Gazette of the 17th July last.

Foreign-Office, November 29, 1855.

THE Earl of Clarendon has received a Despatch from Major Simmons, Her Majesty's Commissioner attached to the army of Omer Pasha in Asia, of which the following is a copy:

Camp, Shangwano, My Lord, 7th November, 1855.

I HAVE to inform your Lordship that Omer Pasha, having collected a depôt of provisions at Tchimshera, moved on by the sea-coast to the mouth of the River Ertiss-Tchal, where a standing bridge was immediately constructed for the passage of the troops. The advanced guard, consisting of 16 battalions of infantry and 3 battalions of chasseurs under Lieutenant-Colonel Ballard, the whole commanded by Ferhad Pasha (Baron Stein), moved on the 28th of October to the village of Ertiss-zkalsk.

From that day until the 1st November, his highness was occupied in sending up provisions to the advanced guard, in moving other troops to support it, and in establishing depôts at Godova, at the mouth of the Ertiss-Zchal, whence to provision his army for a forward movement.

sion his army for a forward movement.

On the first instant, the advanced guard moved about ten miles forward, having its advanced posts on the River Ingur, opposite an old ruined castle called Rooki, on the road to Sugdidi.

His highness joined the advanced guard himself on the 3rd instant, his total force consisting of 4 brigades (32 battalions) of infantry, 4 battalions of chasseurs, and 1,000 cavalry, with 27 field pieces and 10 mountain guns, or in all about 20,000 men; the remainder of his force, about 10,000 men, being employed to protect the depôts at Godova, Tchinshera, and Soukoum.

On the 4th instant, his highness commenced constructing batteries on the right bank of the Ingur, with the view of menacing the enemy by the ford at Ruki. These batteries were armed on the following night, and opened their fire on the morning of the 6th instant about noon. On the same morning his highness moved 3 brigades of infantry (24 battalions) with 3 batteries, with an advanced guard of  $3\frac{1}{2}$  battalions of chasseurs and four guns, under the command of Colonel Ballard, down the right bank of the river, a distance of about seven miles, where a branch of the river was forded to an island, which is some miles in length, and from a half to two miles wide.

After proceeding along this island for about two miles some Mingrelian militia were encountered near a ford, which crosses from the island to the left bank of the river; they speedily retired, when the enemy opened a fire of artillery and a heavy fire of musketry from the intrenchments on the left bank, thrown up for the protection of the ford.

It very soon became evident, that to force a direct passage at this ford would be a very difficult undertaking.

His highness, therefore, while occupying the enemy at this ford, sent officers to the right and left, and fords were discovered in both directions; one about three quarters of a mile above or to the left of the main ford, the other about one mile and a half below or to the right of the main ford.

Troops were immediately sent to pass these fords; that to the left was unprotected. The passage was made by two battalions of infantry and three companies of chasseurs by about 4 p.m. His highness having entrusted me with this command I moved them by a waggon track through the forest unperceived by the enemy, until within about 600 yards of the position at the main ford, which his troops were occupied in defending from a direct attack. The Turkish troops advanced readily to the attack, taking the enemy and his intrenchments in reverse.

The enemy immediately fell back, and attempted to break through the Turks in column, but being met by a heavy fire in their front and on both flanks, they broke and dispersed in the forest, leaving us masters of the field, with 3 pieces of their field artillery and 6 ammunition waggons in our possession. At the moment that the Russian columns attempted to break through our line, I grieve to say that my aide-de-camp, Captain Dymock, 95th Regiment, having first had his horse killed under him, was wounded close by my

side, encouraging the Turkish troops. He died soon afterwards. His death is to be deplored, as Her Majesty has lost in him the services of a most promising and brave young officer, for whom his highness Omer Pasha has frequently expressed to me his high esteem. This young officer had accompanied me from the commencement of the war in Turkey.

Whilst this operation was proceeding on the left, a brigade moved down to the right, under Osman Pasha, and forced a passage in front of a force believed to be of 4 battalions, but without artillery and not entrenched. This operation succeeded; and soon after dark the Turkish forces on the left bank were in communication from right to left, and complete masters of that side of the river throughout this length.

The loss on the side of the Turks has been 310 killed and wounded, of whom 68 are killed, and 4

His highness has been pleased to express himself in terms of the highest satisfaction of the conduct of the British officers who accompanied his force. Lieutenaut-Colonel Ballard conducted the advanced guard, and sustained a very heavy fire from the enemy at the principal ford, about 100 yards wide, from noon until dark at 5 P.M., occupying the enemy until his position was turned by the Turkish left.

Captain Caddell also rendered good service, attached as Second Senior Artillery Officer to that branch of the service. His interpreter was

The loss on the side of the enemy has not yet been ascertained, but up to the present time (noon) 347 have been buried, of whom eight officers, among which the prisoners report there are two colonels.

The prisoners report that there were eight battalions of infantry, besides a great number of Mingrelian militia opposite the main ford.

The QUEEN'S Most Excellent Majesty in Council.

W HEREAS ships arriving from foreign parts at ports or places within the United Kingdom, and proceeding in ballast to other ports or places within the United Kingdom, for the purpose of taking on board cargo for delivery within the United Kingdom are not exempted from compulsory pilotage when so navigating in ballast.

And whereas it is expedient that such ships

And whereas it is expedient that such ships should have the privilege of being exempt from compulsory pilotage.

And whereas by the 332nd section of the "Merchant Shipping Act, 1854," it is enacted, that "every pilotage authority shall have power by "bye-law, made with the consent of Her Majesty "in Council, to exempt the masters of any ships, "or of any classes of ships, from being compelled "to employ qualified pilots, and to annex any "terms and conditions to such exemptions."

And whereas the Trinity House, being a pilotage authority, hath submitted, for the consent of

Her Majesty in Council, the following bye-law videlicet:-

"That all ships which shall arrive from foreign parts at ports or places in the United Kingdom, within the pilotage jurisdiction of the Trinity House, shall when navigating from thence in ballast to a port or place in the United Kingdom, for the purpose of taking on board cargo for delivery at some other port or place in the United Kingdom, be exempt from compulsory pilotage while navigating within the limits of such pilotage jurisdiction, subject, nevertheless, to the terms and conditions following, that is to say:—

"First. That the owner or master of the ship claiming exemption from such compulsory pilotage shall provide himself with a certificate of such exemption for the particular voyage therein specified; such certificate to be signed by the secretary or other proper officer of the Trinity House, and to be delivered to the owner or master of such ship, upon his making a declaration, setting forth that the said ship last arrived from foreign parts, and is about to navigate in ballast to some port or place in the United Kingdom, for the purpose of taking on board cargo, for delivery at another port or place, also in the United Kingdom, and such ports or places being named in such declaration. And further, that the master of such ship shall produce the said certificate, to any duly licensed Trinity House pilot, who shall offer his services to pilot such ship on such voyage; and such master shall on every such occasion, make an entry in the ship's log, of the offer by a Trinity House pilot; of the certificate of exemption having been produced to the said pilot; and of his services having been declined.

"Second. That in every case in which a certificate of exemption shall have been obtained by misrepresentation, the person on whose application such certificate shall have been granted, shall forfeit double the amount of the pilotage to which the ship so exempted would, but for such certificate, have been liable; to be recovered in like manner as penalties are recoverable under the said Act; and

"Third. That in every case in which a ship, for which a certificate of exemption has been granted, shall proceed over sea, either before or after arriving at the port or place specified in such certificate, without navigating with cargo to some other port or place in the United Kingdom, the pilotage to which such ship would have been liable, had a pilot been employed, shall be paid to the pilotage authority or sub-commissioners of the district, and be applied to the purposes of the pilotage fund."

Now, therefore, Her Majesty having taken the said bye-law into consideration, is pleased, by and with the advice of Her Privy Council, and by virtue of the power vested in her by the said recited Act, to declare her consent to the same, and the said bye law is hereby approved accordingly.
